

# OPEN BOOTH SELECTION FOR 2019 AMUSEMENT EXPO

**Show Dates: Tuesday, March 26<sup>th</sup> – Thursday, March 28<sup>th</sup>**  
**Booth Set up dates: Monday March 25<sup>th</sup> & Tuesday, March 26<sup>th</sup>**  
**Las Vegas Convention Center, North Hall**

**Open booth selection will begin Monday, November 5<sup>th</sup> at 8:00am PST.** To select booth space, please call the NBVA at 480-302-5998 or email [admin@nbva.org](mailto:admin@nbva.org). No early selections, please. Booth selection will be first-come, first-served. Booths cannot be held; a deposit must be paid at the time of selection to claim the booth space.

All Exhibitors must be **NBVA Supplier members**. You can view and pay for membership here:

Membership will be due December 31<sup>st</sup>, 2018. All exhibitors will be invoiced for membership prior to the show, if they have not already paid.

Exhibitors will receive two (2) badges with the purchase of each booth. New member badges are \$75.00 per person. Current NBVA Member badges are \$100 per person, until January 10<sup>th</sup>. After January 10<sup>th</sup>, badges are \$125 per person. Additional badges can be indicated on the booth space contract.

## BOOTH PAYMENT OPTIONS

### BOOTH PRICING

Each 10' x 10' booth is \$1,995.00

Each 10' x 10' Corner booth, including the \$150 fee, is \$2,145.00

### 1% DISCOUNTED BOOTH PRICING

**For booth payment in full at the time of section**

Each 10' x 10' booth is \$1,975.05

Each 10' x 10' Corner booth, including the \$150 fee, is \$2,133.55

### BOOTH SPACE DEPOSITS

A 30% booth space deposit will be due at the time of selection. Failure to pay in full by this date may result in forfeiture of your booth space.

### REMAINING BOOTH FEE DUE DATES

- Payment in full at the time of selection will be eligible for a 1% discount
- Remaining payment in full is due February 1<sup>st</sup>, 2019
- Booths selected after February 1<sup>st</sup>, payment in full is due March 1<sup>st</sup>.

## PAYMENT PLANS

**Auto charge option:** The NBVA can set up auto payments so exhibitors can pay 20% due each month (or other terms due to time constraints). Not eligible for discounts

**Self-pay option:** The exhibitor can log into their online invoice and pay any amount securely at any time. Not eligible for discounts

Payment in full will be due February 1st.

## NBVA Membership

NBVA membership must be paid in full prior to exhibiting. All Exhibiting companies must have a Supplier- level membership. NBVA Exhibitors will be invoiced in December. Membership can also be purchased online here:

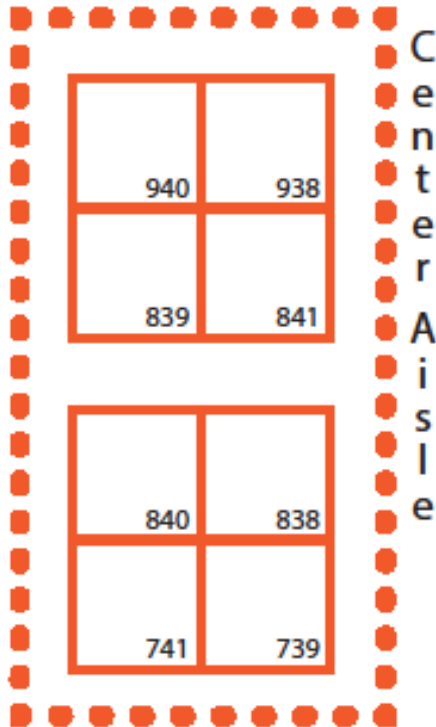

## BOOTH CANCELLATION POLICY

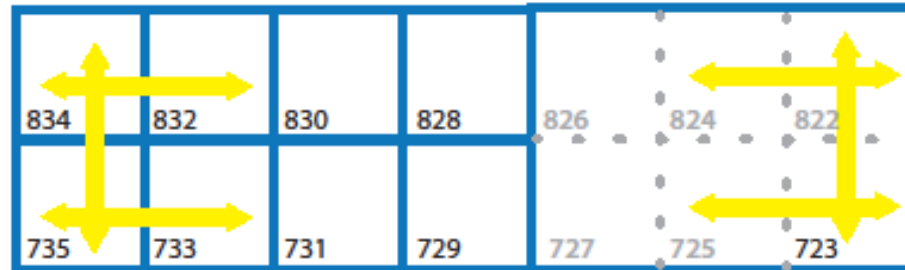
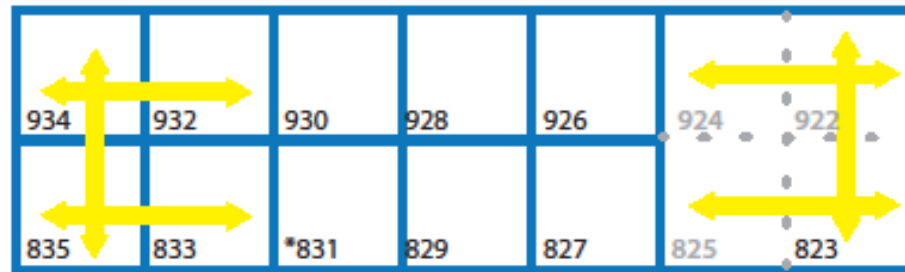
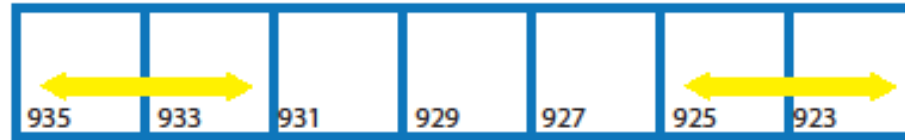
- No Charge: 30 Days after booth selection date
- 10% Penalty: 31 days after selection date to 30 days before show date (Sunday, February 24th, 2019)
- 50% penalty: within 30 days before show dates (Sunday, February 24<sup>th</sup>, 2019)

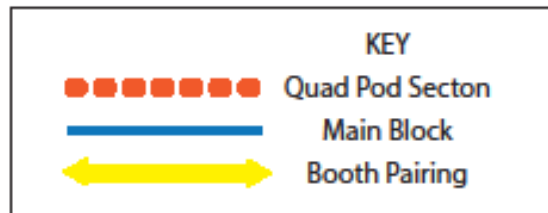
**Quad Pod**

 \$150 corner fee applies

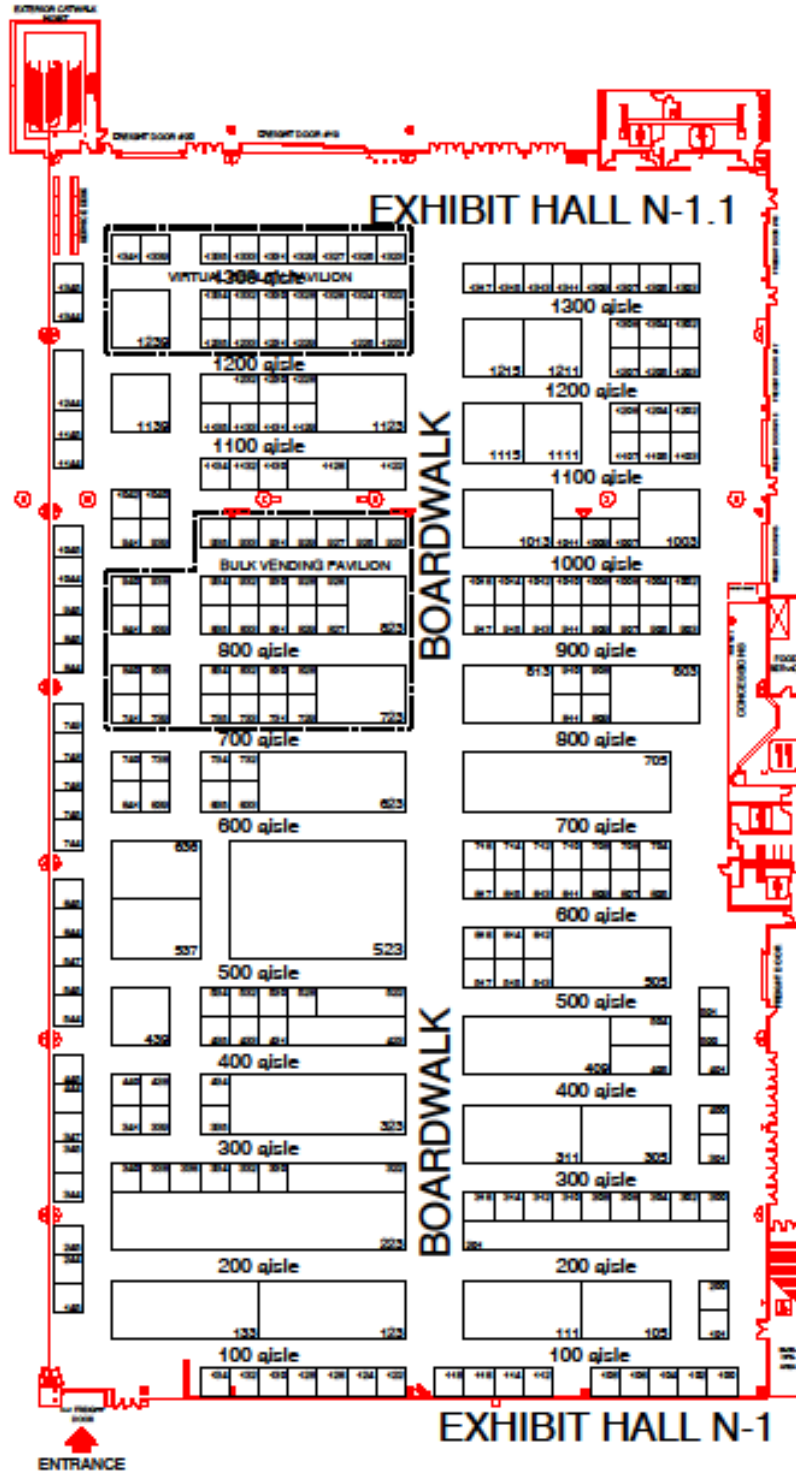


**Main Block**

## BONUS BADGES

### BONUS BADGES

Each exhibitor will receive bonus badges with each booth purchased. These badges will include the guest's name, company, city, state and indicate the company they are a guest of. (Bonus badges are separate from the booth badge allotment). These bonus badges can be assigned to anyone the exhibitor would like, as long as the NBVA is notified, in writing, using the bonus badge form, by March 1st.

### BONUS BADGE ALLOTMENT

For each booth purchased prior to January 1<sup>st</sup>, 2019 and deposit paid in full, the exhibitor will have **2** bonus badges to assign. For each booth purchased after January 1<sup>st</sup>, 2019 and deposit paid, the exhibitor will have **1** bonus badge to assign. **Bonus badge forms will be sent to exhibitors after their booth deposit is paid.**

The bonus badge allotment is separate from the badges included with the purchase of each booth space. Booth badges allow the wearer into all NBVA events, bonus badges only allow the wearer on the show floor on Thursday. Please see chart below for explanation

**Bonus badge forms will be sent to exhibitors after they have selected their booth space and paid their booth deposit.**

### BONUS BADGE RULES

- Only good for the last day of the show (No early entry, valid on Thursday March 28<sup>th</sup>, 2019 only)
- Will NOT get the wearer into the seminars or other events
- Only assigned by the exhibitor using the bonus badge form prior to March 1<sup>st</sup>, 2019
- May not be sold or traded.
- No early pick up. Badges can only be picked up on Thursday March 28<sup>th</sup>, 2019
